Plainfield Public Library, 2009 award winner

The Plainfield Public Library has been named winner of the 2009 Community Change Award by the New Jersey Black Issues Convention (NJBIC), for its unique Diversity Studies Collection. This study collection contains published and unpublished resources on the history, culture and literature of African-Americans, including photographs and oral histories.

According to Library Director Joe Da Rold, the Diversity Studies Collection is an expansion of its award-winning local history collection. "The development of our Diversity Studies Collection has led to exciting partnerships within Plainfield's African American community.

This has resulted in the donation of 5,000 photographs and 2, 000 books on African -American culture and history from two local residents." *(cont. p. 3)*

New Jersey through Artists' Eyes: Garden State Iconography exhibit

Referred to as the barrel tapped at both ends or by its various highway exits (as opposed to its actual towns, landmarks, and scenery), New Jersey has consistently had its own imagery overshadowed, mimicked, or at worst, ignored. However, artists born, raised, or residing off of those exit ramps, have long made a career out of documenting various iconography of the state. Some of those artists collected by the Newark Public Library has collected over its 120-year history are on view in *New Jersey Through Artists' Eyes: Garden State Iconography*.

The featured artist of the exhibition is Helen Frank, a Springfield artist raised in Newark and Maplewood, who is known for depicting images of the state: children walking on the Jersey Shore, a busy commercial street in Newark, and even the vacant parking lot of the local Pathmark. Also included is the work of Helen M. Stummer of Metuchen, a self-described "visual sociologist" who has made a career of documenting the life of Newark innercity families. A special tribute is made to Lucille Hobbie, born in Boonton, who passed away in 2008; Morris County imagery is synonymous with Hobbie, who used many of the historic sites of the county in her work. The exhibition includes the work of Hoboken-based artist Peter Homitzky, Glen Ridge artist Joseph Konopka, former Newark City Surveyor and photographer Donald Farkas, as well as several nineteenth century engravers.

The collection is housed in the library's Archives Room, where items are shelved under optimal environmental conditions and under tighter security than in the main Reading Room, thus reducing ducing the risk of theft of rare and important titles.

Plainfield Public Library's Local History Department has started a Memoir Writing group. The first meeting was held on October 29, 2009. The impetus for this group was generated by interest in the *Lost But Not Forgotten* exhibition. C3NJ Task Force and Symposium

On October 2nd, H&P Vice President Nancy Madacsi, Member-at-Large Michele Stricker and I were among the attendees at a symposium held by the Collections Care Consortium of New Jersey (C3NJ), which is the group implementing a statewide assessment of conservation needs throughout NJ, funded through the IMLS Connecting to Collections grant. Among the presentations was a "sneak peek" at the results of the statewide survey of libraries, museums, and archives

conducted during the past year. While the full report is yet to be made public, one startling statistic bears an early mention: of the number of reporting libraries and archives, nearly 60% reported that less than half of their special collections were cataloged/processed. That number is of course pushed up by the amount of underprocessed materials in archival institutions, but it does reflect a situation in libraries as well.

There will be another meeting of the Task Force on November 30. As the results are fully processed and the report is made available, we will keep the History and Preservation section informed so that we can help to disseminate the findings and recommendations produced. In addition to inventory, the report will address the full range of services and skills needed to conserve our historical materials and make them accessible to the public, from preservation to marketing. Hopefully, a framework of best practices based on a survey sponsored by IMLS will be useful for institutions seeking funding for individual projects going forward.

Poster session participants place materials such as pictures, data,

graphs, diagrams and narrative text on 4' x 8' poster boards or poster

triptychs. Posters should be free standing because wall space cannot be guaranteed.

During their assigned time periods, participants informally discuss their presentations with conference attendees.
