- Technology Denise O'Shea
  - a. Meeting with IT Committee who will co-sponsor panel on e-book readers. Public and Academic library representations
  - b. Digitization program and tech forum programs proposals submitted.
  - c. No formal applications yet for technology innovation award. Reminder will be sent soon. February deadline.
  - d. MM and DO will meet to review website for CUS.
- User Education Ma Lei Hsieh (by email)
